INSTRUCTIONS

1. Each token may be used towards the purchase of tobacco (whether pipe tobacco, cigarettes or any other form of manufactured tobacco) or snuff from a licensed tobacco dealer on, but not before, the date printed on the token, or within three months after that date.
2. You must not detach the tokens yourself, but must hand this book to the tobacco dealer and let him detach them. It is an offence for a tobacco dealer to accept loose tokens.
3. The tokens are not transferable and must be used only for the
