4. The age given by you on collations twill be accepted as your true age, and you will be liable to beld to serve on the engagement for which you artise notwithstanding that at some future date you may prove that your age given on enlistment is incorrect. You will not, however, be eligible for family allowance until you attain the true age at which family allowance will be issuable.
