



# DRIVING LICENCE

THE MOTOR VEHICLES (DRIVING LICENCES) REGULATIONS, 1937.

Groups of Vehicles.

I. Heavy locomotive, light locomotive, motor tractor, heavy motor car, motor car, or motor tricycle equipped with means for reversing (excluding any vehicle comprised in Group IV or Group VI).

NOTE. — An additional licence must be obtained before a Public Service or a Heavy Goods Vehicle may be driven.

II. Trolley Vehicle.

III. Motor Bicycle (with or without side-car) or tricycle not equipped with means for reversing.

IV. Track-laying vehicle steered by its tracks.

V. Invalid carriage.

VI. Mowing machine, agricultural tractor or vehicle controlled by a pedestrian.

**Conditions attached to the  
driving of Motor Vehicles by  
the holder of a Provisional  
Licence.**

The holder of a provisional licence, when driving any vehicle which he has not qualified by test to drive, must carry the prescribed " L " plates at the front and back of the vehicle. He must also be accompanied by the holder of a current licence who has passed the driving test, or held licences to drive for not less than two years. This condition does not apply to a solo motor bicycle or to any other vehicle not constructed or adapted to carry more than one person ; the holder of a provisional licence must not, however, carry any pillion passenger except a licence-holder qualified as above when driving a solo motor bicycle.
